40 Years Ramsar Convention – Conference in Helsinki

An international conference on “The Future of Wetlands – 40 Years of Global Wetland Conservation” is held on **25 October 2011** in Helsinki, Finland. The Conference addresses the following themes: Why are wetlands relevant? What is the state of wetlands? How should we interact in order to find more efficient and sustainable solutions? How to increase the political commitment for future? The 2010 Biodiversity Target was an overall conservation target aiming to

halt the decline of biodiversity by the end of 2010. The world largely failed to meet the target. Especially the state of wetlands has deteriorated more than the state of other ecosystems. The Conference is organized and funded by the Ministry of the Environment, Metsähallitus Natural Heritage Services and the Nordic Council of Ministers. IPS will be represented by Secretary General Jaakko Silpola. The panel discussion: "The future of wetlands?" will be moderated by Tobias Salathe, Senior Advisor, Ramsar Secretariat. Lithuanian Peat Industry 2011: Optimism with Spices of Concern

After two rainy seasons, the Lithuanian peat producers met the year 2011 with optimism and hope. Several new peat companies and active young people joined the Peat Producers' Association "Lithuanian Peat" and the activities became more stirring and interesting. In 2011, the Association united nearly all Lithuanian peat companies. This has strengthened the work much more, consolidated common aims and facilitated decision making. Lobbying work became more active when working with various governmental institutions.

Weather conditions allowed starting peat extraction even earlier than in the previous years. Spring and the beginning of summer were promising, especially after the rainy 2009-2010, when peat extraction dropped by half, compared to the year 2008. However, July and August of 2011 were very rainy, especially in the western districts of the country. Not even half of the planned amount of peat was collected. Companies began calculating tremendous economic loss after three successive rainy seasons. Besides this, the Lithuanian Government prepared a new law project for a tax for natural resources, including an increase of tax for extracted peat by more than three times.

The Association carried out a peat profit and cost economic analysis, which revealed that such tax increase is not based on any economic calculations and may result in peat companies' bankruptcy, which would cause serious negative social consequences. The State's concern to use natural resources more rationally is clear, however, it should be justified by economic arguments. After long and serious debates with governmental institutions, the decision to increase the peat extraction tax is temporarily suspended. However, concern about the future of the peat industry remains.

It is gratifying that our neighbouring Latvians brightened the mood in the middle of September and organized a lovely and impressive forum of Baltic countries' producers in Riga. We are grateful to our Latvian colleagues for their inspiring good mood and optimism. (*Juozas Daukantas*)

New Book in German: The World's Sphagnum Species (2011)

Michaelis' new illustrated German language monograph documents worldwide Sphagnum species (peat mosses) and provides a key for them. It is the first synoptic documentation since Carl Warnstorfs seminal „Sphagnologia Universalis“ (1911). Since that time, many names were recognized as synonyms and revised, particularly by Andrews, Eddy und Isoviita. These revisions, plus approximately 150 valid newly described species and many data by the author are presented in the book. Genetic studies were used to distinguish problematic species. Different approaches to subdivide Sphagnum are available, which yield up to four subspecies and up to 18 distinct sections, 13 of which are distinguished by this author, among them the newly established section Lapazensis.

The author initially describes the anatomy and morphology of Sphagnum, and expands this to describe its reproductive biology, evolution and the history of peat moss research. The systematic part is subdivided in three sections: subdivision and description of the sphagnum sections, identification key for all peat moss species and lists of sphagnum species for 19 regions worldwide. Keys for Africa, Europe and North America are based on previously available data, and completed by adding recent descriptions, new species concepts and new floristic data. The keys for South America and Asia are new, because previously there were none.

286 Sphagnum-species are exhaustively described, supplemented by data on habitats, geographic distribution and synonym lists. Internal and external features are depicted on 194 plates.
